ASSEMBLY VIEW



- Remove the 3 OEM bolts in the locations circled in the picture above.
- Thread the 75mm bolts (**Item 5**) through the 45mm spacers (**Item 3**) washers (**Item 7**) and slider (**Item 1**) in the locations circled in red in the fitting picture.
- Repeat this process with the 80mm bolt (Item 6), the 51mm Spacer (Item 4) and remaining washer (Item 7) in the location circled in yellow.
- Offer the assembly up to the bike as shown in the fitting picture above and tighten the bolts fully.


