



ITEM 3 = M8x1.25x20mm LONG HEX HEAD BOLTS, THREE PER SIDE (x6).


ITEM 4 = RIBBED FINISHING INSERT, ONE PER SIDE (BPCS 283295) (x2).

ITEM 5 = ADVENTURE BAR RIGHT-HAND SIDE (CB011) (x1).


# **TOOLS REQUIRED**

- Socket set to include a 13mm socket and wrench.
  - Torque wrench (up to 20Nm).










4. PICTURE FOUR

# **Left-hand side (as you sit on bike)**

- Remove the three plastic push covers in positions arrowed in pictures TWO and THREE.
- Offer the left-hand side adventure bar into position and using the three M8 washers and three M8 bolts secure into position as shown in picture ONE. **Do not exceed 20Nm torque.**

# Right-hand side (as you sit on bike)

- Remove the three plastic push covers in positions arrowed in pictures FIVE and SIX.
- Offer the right-hand side adventure bar into position and using the three M8 washers and three M8 bolts secure into position as shown in picture TWO. **Do not exceed 20Nm torque.**

#### **R&G RACING RETURNS POLICY (NON-FAULTY GOODS)**

Returns must be pre-authorised (if not pre-authorised the return will be rejected). Goods may only be returned direct to us if they were purchased direct from us (customer must prove if necessary). Otherwise to be returned to original vendor. Goods must be in resellable condition, in the opinion of R&G Racing. All returns are subject to a 25% restocking and handling fee (25% of the gross value exc. P&P – at the prevailing price at time of purchase). The customer must pay any and all carriage charges. No returns of discontinued products, unless within 14 days of purchase. This policy does not affect your statutory rights and does not refer to faulty goods.

Merci de noter que dans le cas où les protections sont assemblées avec une bague en caoutchouc, merci de bien vouloir le retirer lors du montage des pièces sur la moto. Ne pas commencer le montage des pièces s'il manque une ou plusieurs pièces.

### **LEGENDE**

ART 1 = Protection gauche (CB010) (x1).

ART 2 = Rondelles M8 (x6) 3 par côté.

ART 3 = Vis M8x1.25x20mm (x6) 3 par côté.

ART 4 = Bouchons (BPCS 283295) (x2).

ART 5 = Protection droite (CB011) (x1).

# **OUTILS NECESSAIRES**

- Jeu de clef à douille 13 mm.
- Clef dynamométrique (sup à 20Nm).

# **COTE GAUCHE**

- Enlever les trois couvercles en plastique montrés dans les images 3 et 4
- Placer la protection gauche en position sur la moto et utiliser les 3 rondelles M8 et les 3 vis M8 fournies dans le kit. Serrer au couple de 20 Nm.

# **COTE DROIT**

- Enlever les trois couvercles en plastique montrés dans les images 5 et 6
- Placer la protection droite en position sur la moto et utiliser les 3 rondelles M8 et les 3 vis M8 fournies dans le kit. Serrer au couple de 20 Nm.
