



**FITTING INSTRUCTIONS FOR FI0131BK FRAME INSERT  
SUZUKI GSX-R1000 '17- RIGHT SIDE SWINGARM PIVOT**



**THIS KIT CONTAINS THE ITEMS PICTURED AND LABELLED BELOW.  
DO NOT PROCEED UNTIL YOU ARE SURE ALL PARTS ARE PRESENT.**

**Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike**

THE PARTS SHOWN MAY BE REPRESENTATIVE ONLY (FOR CLARITY OF INSTRUCTIONS ONLY)

Please note that in cases where kits are packed with rubber washers holding the components onto the bolt – *the rubber washers should be thrown away!*

**TOOLS REQUIRED**

- 3mm metric Allen key.

**FITTING INSTRUCTIONS**

- Fit the button head bolt through the frame insert so the head sits in the counter-bore.
- Place special nut on the exposed end of the bolt so it goes into the tapered slot.
- Tighten bolt until the nut just contacts the tapered face of plastic frame insert.
- Place the assembly into the frame recess in position shown above.
- Tighten the bolt so frame insert is held in position firmly (do not over tighten).
- Place one of the supplied bubble stickers into the bubble sticker shaped recess to cover the head of the bolt.
- Regularly check to ensure frame insert remains tight.

- Insérer le boulon dans l'insert de cadre de façon à ce que la tête se place dans le contre alésage.
- Placer l'écrou spécial sur l'extrémité du boulon de façon à ce qu'il se place dans la fente conique.
- Serrer le boulon jusqu'à ce que l'écrou entre en contact avec la face conique de l'insert de cadre en plastique.
- Placer l'ensemble dans le creux de cadre dans la position indiquée ci-dessus.
- Serrer le boulon pour que l'insert de cadre soit fixé en position (ne pas trop bloquer).
- Placer un des stickers en caoutchouc dans le creux dédié, pour cacher la tête du boulon.
- Vérifier régulièrement le serrage de l'insert de cadre.
