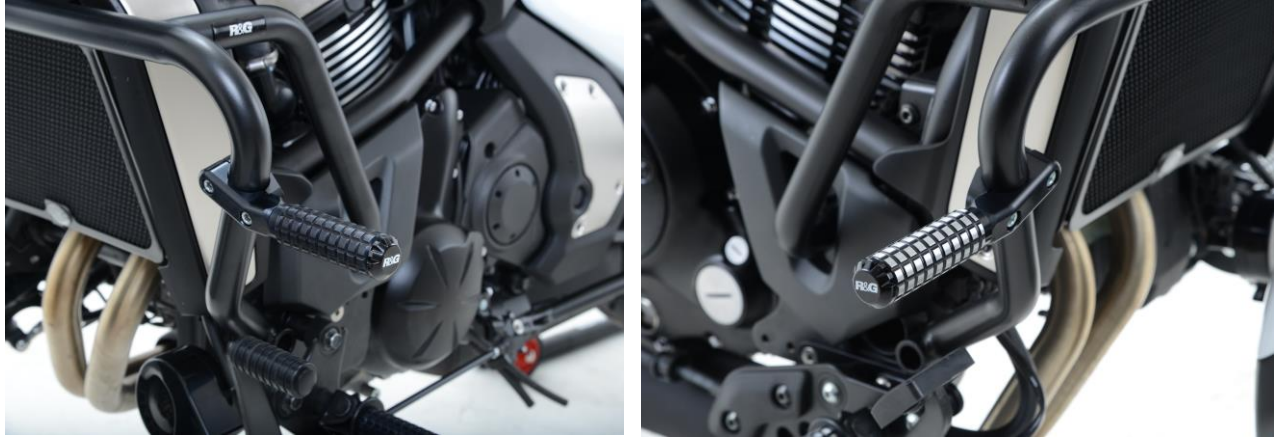

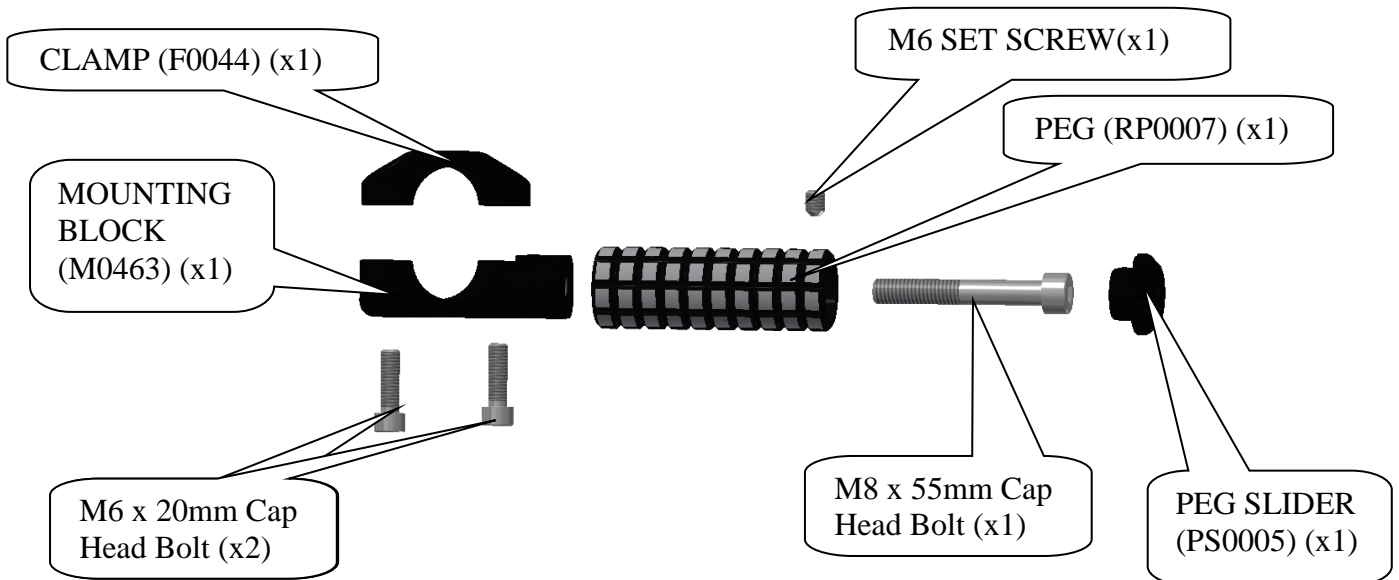

Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike

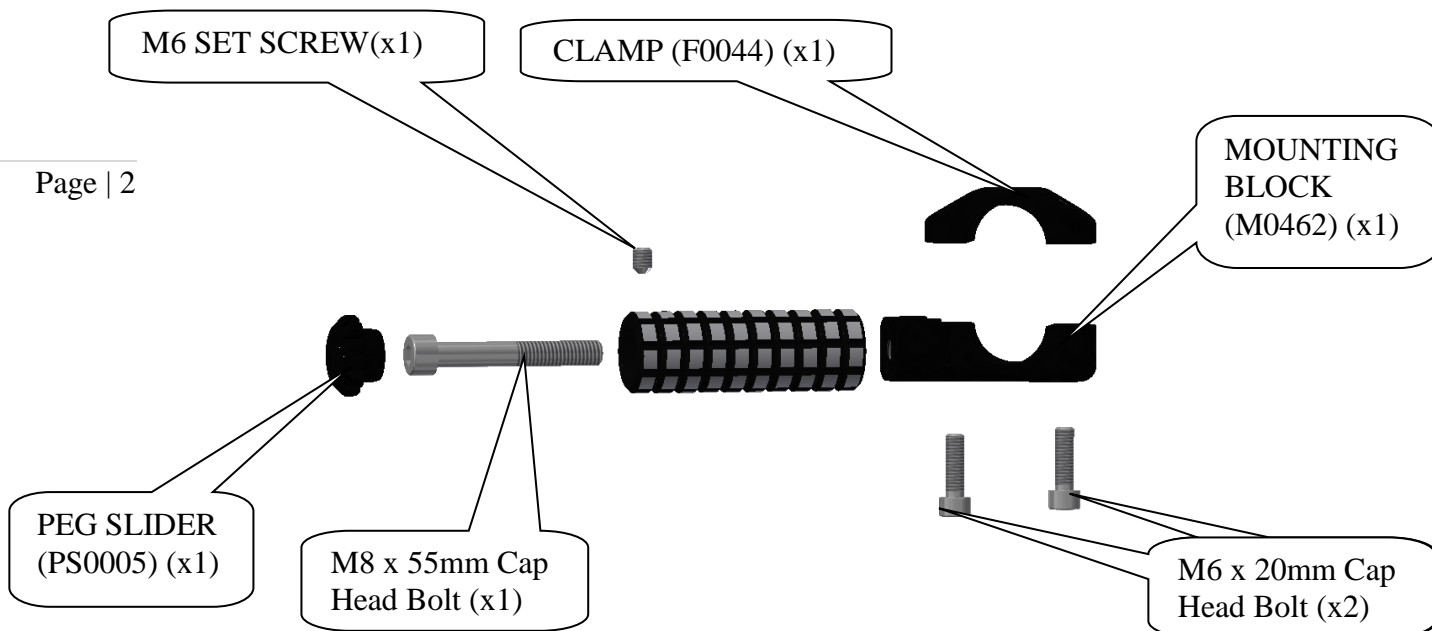

RIGHT HAND SIDE

Please note that in cases where kits are packed with rubber washers holding the components onto the bolt – *the rubber washers should be thrown away!*

TOOLS REQUIRED

- Set of metric Allen keys to include 3, 4 and 5mm A-F.

FITTING INSTRUCTIONS

LEFT HAND SIDE

- Place one of the M8 cap head bolts through one of the pegs so the head of the bolt fits into the counter-bore.
- Engage the exposed thread into the mounting block (M0463) (do not tighten at this stage).
- Place two of the M6 cap head bolts into the mounting block (M0463) so the heads of the bolts fit into the counter-bores in the block.
- Offer this assembly into position as shown in the top left picture ensuring the peg is in a comfortable and usable position.
- Place one of the clamps into position and tighten the two M6 bolts.
- Rotate the peg so the set screw hole is pointing down-wards and tighten the M8 bolt.
- Place the slider into the peg and lock into position using the set screw.
- The assembly may be removed or rotated when not in use.

RIGHT HAND SIDE

- Place the remaining M8 cap head bolt through the remaining pegs so the head of the bolt fits into the counter-bore.

- Engage the exposed thread into the mounting block (M0462) (do not tighten at this stage).
- Place the two remaining M6 cap head bolts into the mounting block (M0462) so the heads of the bolts fit into the counter-bores in the block.
- Offer this assembly into position as shown in the top right picture ensuring the peg is in a comfortable and usable position.
- Place the remaining clamps into position and tighten the two M6 bolts.
- Rotate the peg so the set screw hole is pointing down-wards and tighten the M8 bolt.
- Place the slider into the peg and lock into position using the set screw.
- The assembly may be removed or rotated when not in use.

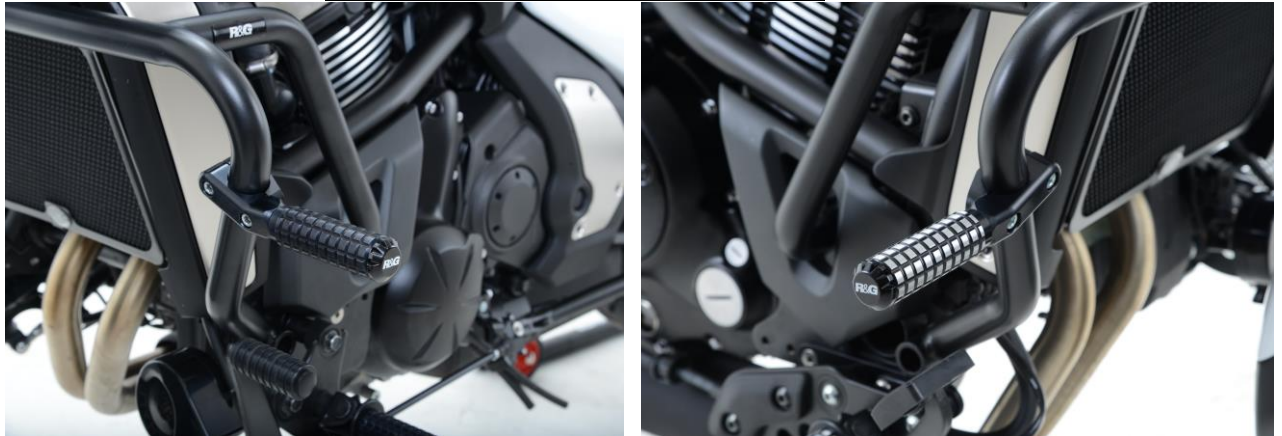

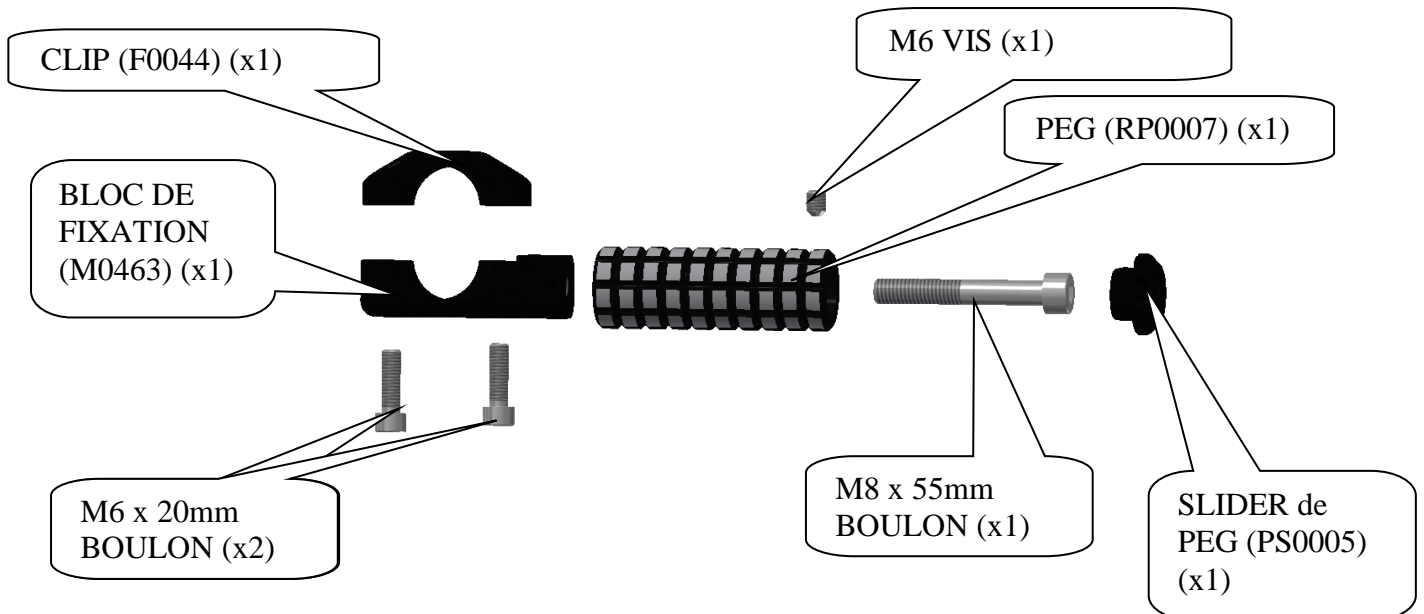

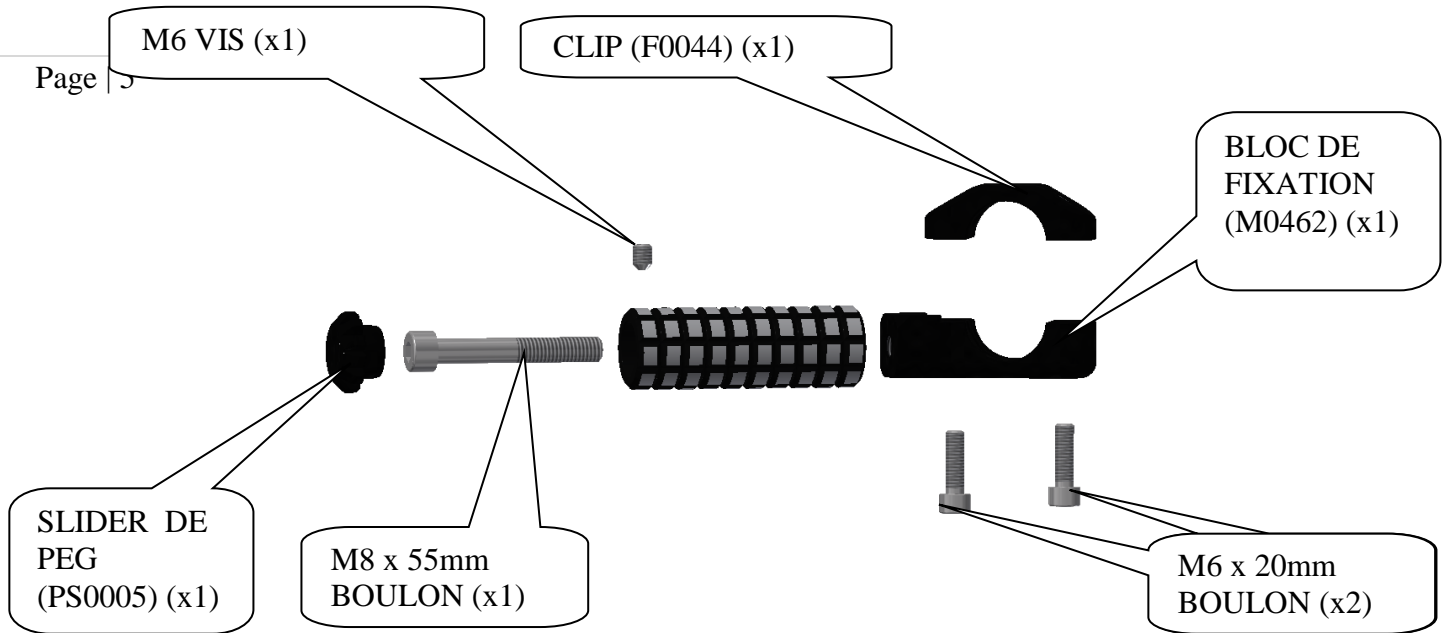

COTE GAUCHE

- Placer un des boulons M8 dans un des pegs de façon à ce que la tête du boulon se place dans le contre alésage.
- Engager le filetage dans le bloc de fixation (M0463) (Ne pas serrer pour le moment).
- Placer 2 des boulons M6 dans le bloc de fixation (M0463) de façon à ce que les têtes des boulons se placent dans les contre alésages du bloc.
- Monter l'ensemble en position comme indiqué sur la photo en haut à gauche, en veillant à ce que le peg soit dans une position confortable.
- Placer une des plaque en position et serrer les 2 boulons M6.
- Tournez le peg de façon à ce que le trou pointe vers le bas puis serrer le boulon M8.
- Placer le slider dans le peg puis bloquer la position en utilisant la vis.
- L'ensemble peut être tourné ou enlevé lorsque vous n'en avez pas besoin.
