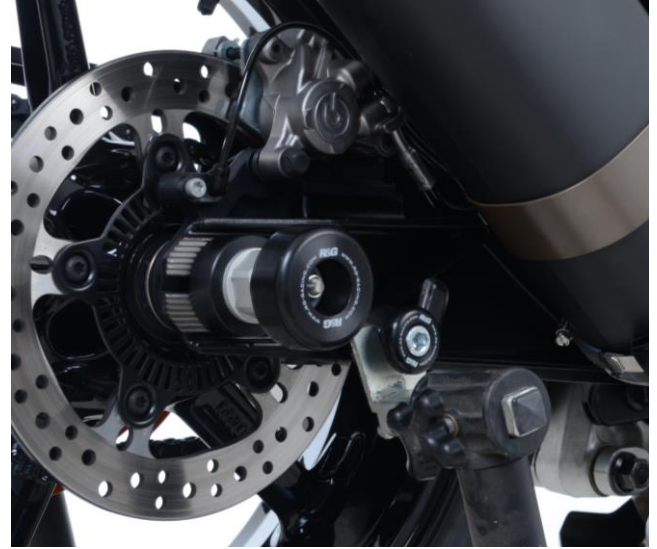




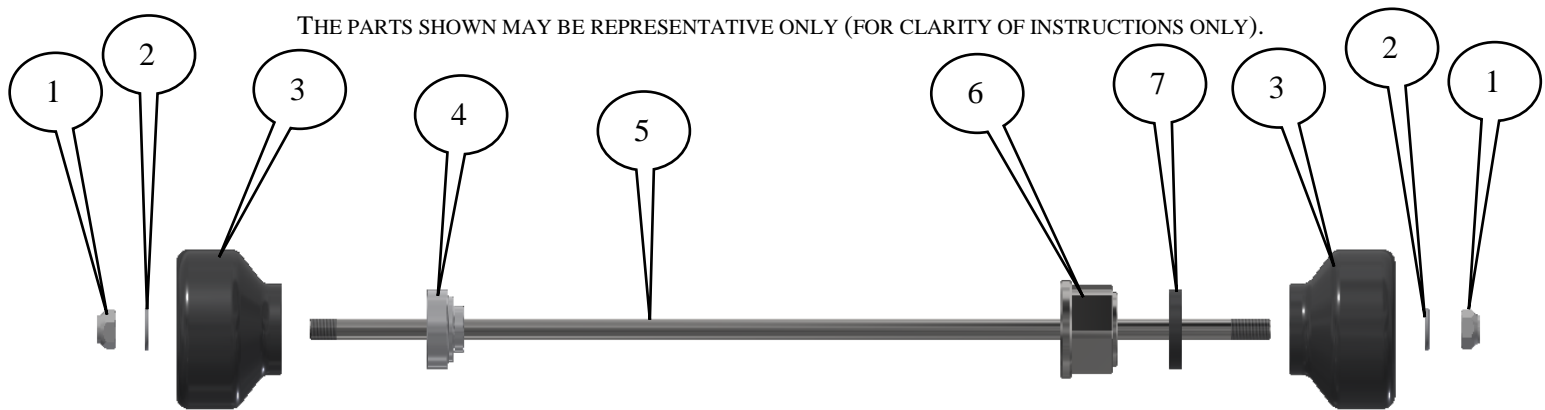
FITTING INSTRUCTIONS FOR SP0083 SWINGARM PROTECTORS
HUSQVARNA VITPILEN 701 2018-

- ITEM 7 = LOCATION SPACER RHS (S0687=5mm wide/plain) (x1).

TOOLS REQUIRED

- 13mm socket and wrench (x2).
- 32mm Socket and Torque Wrench.

MAXIMUM TORQUE SETTINGS

- M4 BOLT = 8Nm
- M5 BOLT = 12Nm
- M6 BOLT = 15Nm
- M8 BOLT = 20Nm
- M10 BOLT = 40Nm

FITTING INSTRUCTIONS

- Remove the original spindle nut on the right-hand side of the rear spindle while supporting the licence plate bracket and replace with the new spindle nut (item 6) from kit and tighten to manufactures torque specification.
- Place the new spindle bar (item 5) through the spindle nut just fitted and the rear spindle so equal amounts protrude from either side.
- Place the larger location spacer (item 4) over the spindle bar and into the rear spindle on the left-hand side so the smaller diameter locates into the spindle.
- Place one of the crash protectors (item 3) over the exposed end of the spindle bar and against the spacer just fitted.
- Place one of the washers (item 2) over the exposed end of the spindle bar and into the counter bore of the crash protector.
- Engage one of the Nyloc nuts onto the exposed thread.
- Place the thinner location spacer (item 7) onto the exposed end of the spindle bar and against the replacement spindle nut already fitted on the right-hand side.
- Place the remaining crash protector (item 3) onto the exposed end of the spindle bar and against the replacement spindle nut already fitted.
- Place the remaining washer and Nyloc nut onto the exposed thread and fully tighten both nuts (please ensure both nuts are fully engaged). Do not overtighten – the Nyloc nuts will hold it tight.

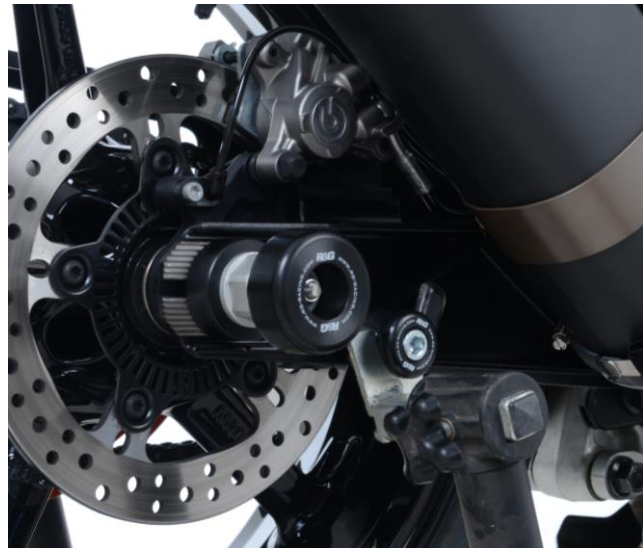

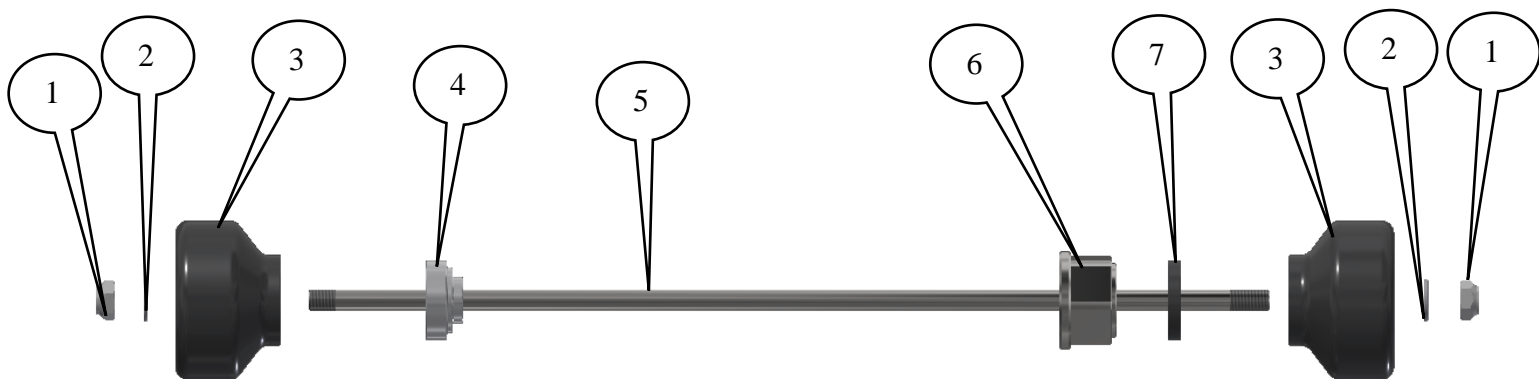

- Clé dynamométrique 32mm.

NOTICE DE MONTAGE

- Enlever l'écrou de moyeu d'origine du côté droit de l'axe arrière tout en supportant le support de plaque puis remplacez le par le nouvel écrou d'axe (article 6) du kit puis serrer à la valeur de serrage recommandée.
- Placer le nouvel axe de moyeu (article 5) dans l'écrou d'axe tout juste inséré et l'axe arrière de façon à ce que la longueur dépassant de chaque côté soit identique.
- Placer l'entretoise (article 4) sur l'axe et dans le moyeu arrière du côté gauche de façon à ce que le petit diamètre se place dans le moyeu.
- Placer une protection crash (article 3) sur l'extrémité de l'axe de moyeu et contre l'entretoise tout juste insérée.
- Placer une des rondelles (article 2) sur l'extrémité de l'axe de moyeu et dans le contre alésage de la protection crash.
- Engager un écrou sur l'extrémité du filetage.
- Placer l'entretoise plus fine (article 7) sur l'extrémité de l'axe de moyeu puis contre l'écrou d'axe de remplacement déjà monté du côté droit.
- Placer la protection crash restante (article 3) sur l'extrémité de l'axe puis contre l'écrou d'axe de remplacement tout juste monté.
- Placer la rondelle restante sur le filetage puis serrer complètement les 2 écrous (veiller à ce que les 2 écrous soient engagés). Ne pas trop serrer – les écrous fixent l'ensemble.

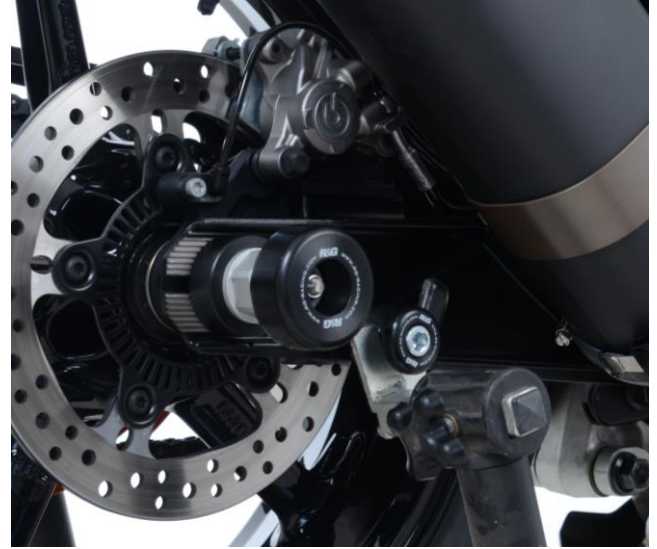

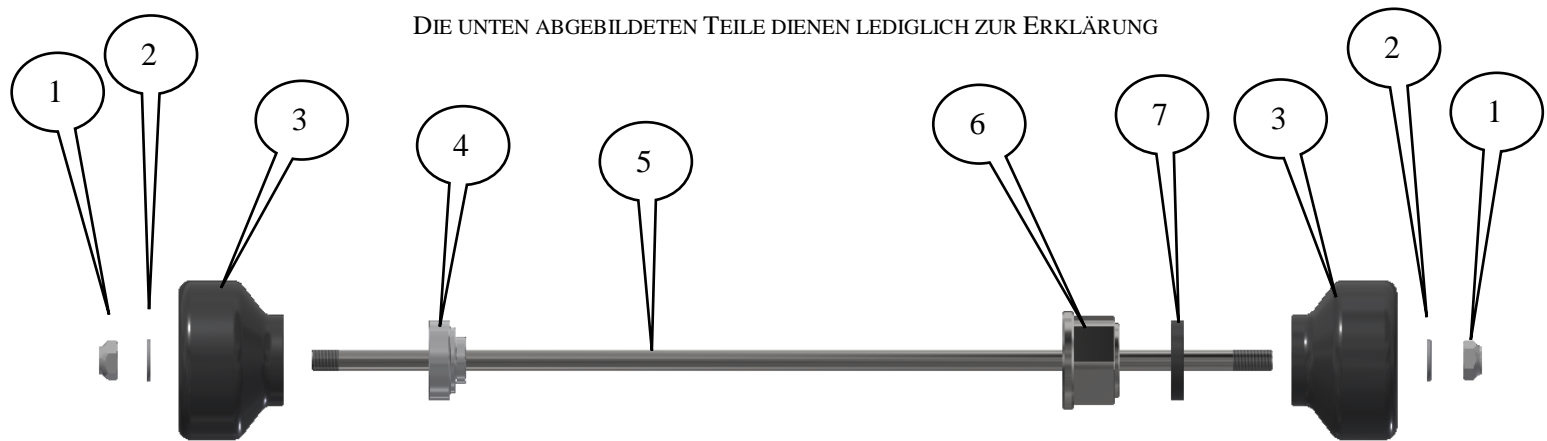

MONTAGEANLEITUNG

- Entfernen Sie die original Radmutter an der rechten Seite der Hinterachse (stützen Sie hierbei den Kennzeichenhalter) und ersetzen Sie sie mit der neuen Radmutter vom Kit (Artikel 6) – mit dem empfohlenen Anzugsdrehmoment des Herstellers befestigen.
- Die neue Verbindungsstange (Artikel 5) durch die soeben montierte Radmutter und die hintere Achse führen, sodass sie an beiden Seiten gleichmäßig hervorsteht.
- Den größeren Distanzhalter (Artikel 4) über die Verbindungsstange in die Hinterachse an der linken Seite einführen, sodass der kleine Durchmesser in der Achse positioniert ist.
- Ein Sturzpad (Artikel 3) über das hervorstehende Ende der Verbindungsstange, am soeben montieren Distanzhalter anliegend, anbringen.
- Eine Unterlegscheibe (Artikel 2) über das hervorstehende Ende der Verbindungsstange in die Gegenbohrung des Sturzpads einführen.
- Eine selbstsichernde Mutter am hervorstehenden Gewinde montieren.
- Den dünneren Distanzhalter (Artikel 7) am hervorstehenden Ende der Verbindungsstange, an der Ersatz-Radmutter an der rechten Seite anliegend, montieren.
