

FITTING INSTRUCTIONS FOR TG0012 TOE GUARD YAMAHA YZF-R1 2015-





THIS KIT CONTAINS THE ITEMS PICTURED AND LABELLED BELOW. DO NOT PROCEED UNTIL YOU ARE SURE ALL PARTS ARE PRESENT.

Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike

Please note that in cases where kits are packed with rubber washers holding the components onto the bolt – the rubber washers should be thrown away!

TOOLS REQUIRED

• Set of metric Allen keys to include 5mm A/F sizes.

FITTING INSTRUCTIONS

- Offer the R&G toe guard into position on the swing-arm and fit the M6 x 20mm long button head bolt (with washer) through the toe guard before tightening into the swing-arm.
- If fitting with paddock stand bobbins please fit behind the bobbin as shown above.
