

ASSEMBLY DIAGRAM





FITTING INSTRUCTIONS

Before fitting remove LHS fairing to make it easier to fit.

- **1.** Remove the bolts located in **<u>Picture 3/4</u>**, do not lose these bolts as they will be reused.
- 2. Assemble the radiator guard as shown in the **ASSEMBLY DIAGRAM**.
- **3.** Place the radiator guard into position on the front of the radiator and place the bolts removed back into the original locations ensuring they are fitted through the new rad guard.
- 4. Once tight then place the new bolt (ITEM 2), washers (ITEM 4) and nyloc nut (ITEM 3) through the hole located in <u>Picture 1/2</u> (as shown in the <u>ASSEMBLY DIAGRAM</u>) and tighten.
- **5.** Ensure all bolts are tight before riding.
- **6.** Refit any fairings that have been removed.

R&G RACING RETURNS POLICY (NON-FAULTY GOODS)

Returns must be pre-authorised (if not pre-authorised the return will be rejected). Goods may only be returned direct to us if they were purchased direct from us (customer must prove if necessary). Otherwise to be returned to original vendor. Goods must be in re-sellable condition, in the opinion of R&G Racing. All returns are subject to a 25% restocking and handling fee (25% of the gross value exc. P&P – at the prevailing price at time of purchase). The customer must pay any and all carriage charges. No returns of discontinued products, unless within 14 days of purchase. This policy does not affect your statutory rights and does not refer to faulty goods.
