



#### **FITTING INSTRUCTIONS**

- To start this fitting process, place one barrel nut (**Item 4**) onto the end of the spindle bar (**Item 1**) and tighten until at least half of the spindle bar thread is inside the barrel nut.
- <u>A fitting suggestion:</u> using a small amount of Loctite on the Spindle bar thread will help create an even number of threads on both sides of the swingarm protector once fully tightened.
- Now slide one crash protector bung (**Item 3**) and one spacer (**Item 2**) onto the bar in the configuration shown in the ASSEMBLY DIAGRAM.
- Slide the assembly through the LHS of the rear spindle. Once through place the other spacer (**Item 2**) and remaining crash protector bung (**Item 3**) onto the end of the spindle bar that's protruding through the LHS.
- Finally, place the other barrel nut (Item 4) over the exposed end of the spindle bar and tighten with two 5mm Allen keys simultaneously to the correct torque using the <u>GENERAL</u> <u>TORQUE SETTINGS</u> table on <u>PAGE 2</u>.





#### **NOTICE DE MONTAGE**

- Pour commencer le montage, placez un écrou cylindrique (article 4) sur l'extrémité de la barre (article 1) et serrez jusqu'à ce qu'au moins la moitié du filetage de la barre soit à l'intérieur de l'écrou cylindrique.
- Suggestion de montage: l'application d'une petite quantité de Loctite sur le filetage de la barre permettra d'obtenir un nombre identique de filetages de chaque côté de la protection de bras oscillant une fois le serrage terminé.
- Glissez ensuite un bouchon de protection crash (article 3) et une entretoise (article 2) sur la barre, conformément à la configuration indiquée sur le SCHÉMA DE MONTAGE.
- Glissez l'ensemble à travers le côté gauche de l'axe arrière. Une fois le montage terminé, placez l'autre entretoise (article 2) et le bouchon de protection crash restant (article 3) sur l'extrémité de la barre qui dépasse du côté gauche.
