FITTING INSTRUCTIONS

- Locate the tapped M8 hole in the bottom of the LHS of the swingarm, as shown in **Picture 1**.
- Align the toe guard (Item 1), bolt (item 2) and washer (item 3) as shown in the assembly diagram and fit loosely in place.
- Note the position of the anti-rotation tab at the rear of the component and place the adhesive foam to protect the swingarm so it sits between the toe guard and swingarm.
- Raise the toe guard so it is as close as possible to the swingarm and tighten the bolt to the recommended torque, so the toe guard is secure.
- Ensure that the sprocket is adequately covered, especially if changing the sprocket from original size or adjusting the chain.
- Check tightness of all bolts regularly, for example when cleaning.
