**TOOLS REQUIRED**

- 2mm Ball ended Allen key.



## **FITTING INSTRUCTIONS**

- Fit the set screw into the frame tidy.
- Place the frame tidy over the exposed nut on left hand side of the motorcycle as shown above, and tighten the set screw.
- Please check regularly to ensure tightness.
