

FITTING INSTRUCTIONS FOR BLP0036BK REAR FOOTREST BLANKING PLATE KTM RC 125/200/390 2014-



Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike

Please note that in cases where kits are packed with rubber washers holding the components onto the bolt – *the rubber washers should be thrown away!*

TOOLS REQUIRED

5 and 6mm A/F metric Allen key.

FITTING INSTRUCTIONS

- Remove rear footrest.
- Fit the two counter-sunk head bolts through the holes in the blanking plate.
- Offer assembly up to bike and engage both bolts as shown in top picture.
- Tighten evenly using 5mm Allen key.
- Repeat for the opposite side.

- Serrer de façon identique à l'aide d'une clé Allen 5mm.
- Répéter l'action du coté opposé.
